



Online Promotions and use of Online Vouchers T&C's 2023

The following Terms and Conditions apply to the use of Arrow Beauty's Online Promotional Vouchers during On-line Promotions and are set out as follows;

1. Arrow Beauty uses Online Promotional Voucher Codes herein called 'OPVC' for use during On-line Promotions via their website (www.arrowbeauty.co.nz)
 - a. Each OPVC will have a specific name eg SUMMER10, AUCKLAND15, EXPO23 etc and this name must be used for the promotion to apply.
 - b. An OPVC may have a denoted discount percentage applicable to that Promotion and that particular OPVC.
 - i. Any percentage discount offered as part of a OPVC will be applied to the item price that excludes GST and Freight
2. An OPVC will have a Commencement Date and Time for when the On-line Promotion begins and a Conclusion Date and Time for when the On-line Promotion ends, herein called the 'On-line Promotion Period.'
 - a. The OPVC cannot be applied prior to the Commencement Date and Time and after the Concluding Date and Time.
 - b. The OPVC can only be applied/used during the On-line Promotion Period.
3. On-line Promotions apply to all Stock items carried by Arrow Beauty with the exception of any Items or Brands listed within these Terms and Conditions (see Clause 8).
 - a. Any product that is Backordered during an On-line Promotion Period will be sent out when Stock is next available.
 - b. Any Backordered items will be sent free of any additional Freight Charge.
 - c. No Stock-Holds or Rain-Checks are allowed.
4. Any OPVC applies ONLY to Orders received Online via the Arrow Beauty website during a particular Promotion Period as per clauses 1 and 2 of these Terms and Conditions and further only applies with the correct application of the applicable OPVC at Checkout;
5. Any On-line Promotion as per clause 1 cannot be amended, substituted or changed in anyway or form from the Promotion that is set out by Arrow Beauty for the purposes of the On-line Promotion.
6. Any OPVC cannot be used in conjunction with any other current offering from Arrow Beauty, Customer Special Pricing, Training Fee, Vouchers, Customer quotation(s), Product supplied in Kit or Stand form or any other Package/Bulk Deal or other form of Discount or Promotion running concurrently with Arrow Beauty during the On-line Promotion Period.
7. Any OPVC does not apply to the following brands and products (unless specifically mentioned that it does within the promotion itself);
 - a. Bondi Sands (with the exception of Bondi Sands Professional 1L Tanning Solution)
 - b. The Whitening Co.
 - c. Ed&I
 - d. All Furniture and Equipment (unless specified)
8. Prices for any On-line Promotion run by Arrow Beauty exclude GST and Freight.
9. Arrow Beauty reserves the right to withdraw/amend/alter/add to or delete any On-line Promotion at any time during the On-line Promotional period.
10. Arrow Beauty reserves the right to amend/alter/add/delete any of these Terms & Conditions prior to, during or after any On-line Promotion.
